

**RELEASE, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT**

The undersigned, as guest(s), licensee(s) and/or invitees of Crittenden Social Club, LLC, a Nevada limited liability company, understand(s) that there are certain risks for personal injury and death, and/or property damage and destruction arising from or in connection with the activities in which they may engage at Crittenden Reservoir, Nevada. This includes activities organized, sponsored, permitted or facilitated by Crittenden Social Club, LLC, to include the use of water craft and fishing equipment, and hazards presented by being in proximity to Crittenden Reservoir. Such hazards include, without limitation, drowning and death, or physical injury caused by exposure to the elements, or caused by water craft, motor vehicles, wildlife or fishing equipment, such as hooks and barbs.

The undersigned agree(s) that the activities associated with the Crittenden Social Club, LLC are inherently dangerous and further agree(s) to assume all risks for personal injuries or death and/or property damage and/or destruction that may result therefrom. The undersigned further agree(s) to indemnify, defend, release and hold harmless Crittenden Social Club, LLC, Winecup Gamble, Inc., and their respective members, officers, agents, employees and representatives (hereinafter "Indemnitees") from and against all liabilities, judgments, penalties, damages, claims, expenses (including reasonable attorney fees and costs incurred by Indemnitees in enforcing this Agreement) resulting from personal injury or death and/or property damage and/or destruction in any manner pertaining to or arising from the use or occupation of real or personal property owned or managed by Indemnitees, or from activities organized, sponsored, permitted or facilitated by Indemnitees, other than intentional acts committed for the purpose of causing physical injury. The preceding sentence shall apply to all harms, regardless of cause, other than intentional torts designed to cause physical injury.

The undersigned represents and agrees that he/she/they has/have and will continue to have the following insurance policies in effect: (1) insurance covering physical injury and death, to include all costs of health care, and transportation from the site of injury to a medical facility, and (2) insurance covering damage to or loss of personal property, to include motor vehicles owned or operated by the undersigned.

The undersigned acknowledge(s) that he/she/they has/have carefully read this document, understand(s) the content hereof, and freely and voluntarily executes the same.

This Agreement shall expire ten (10) years from the date of signature.
